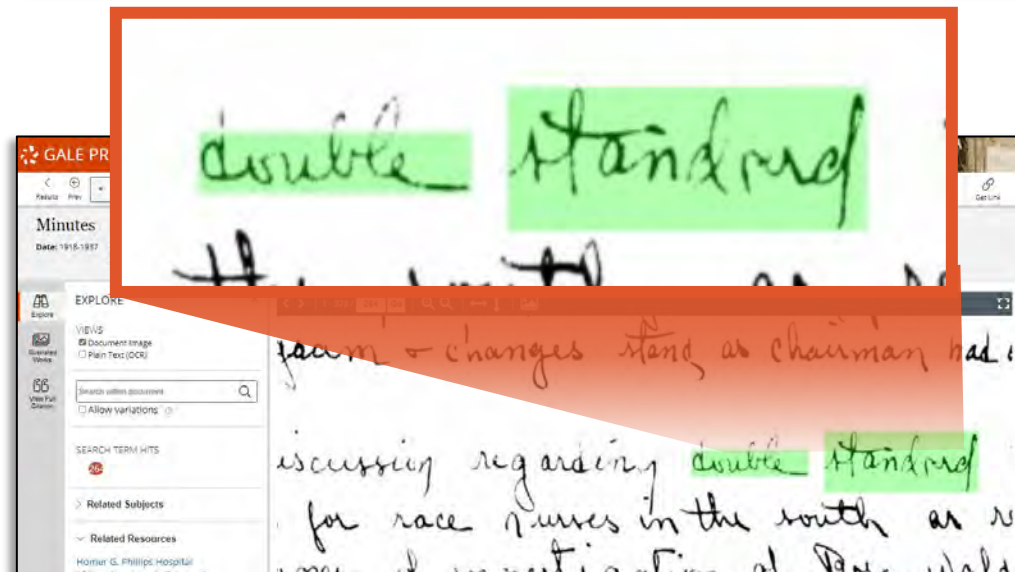
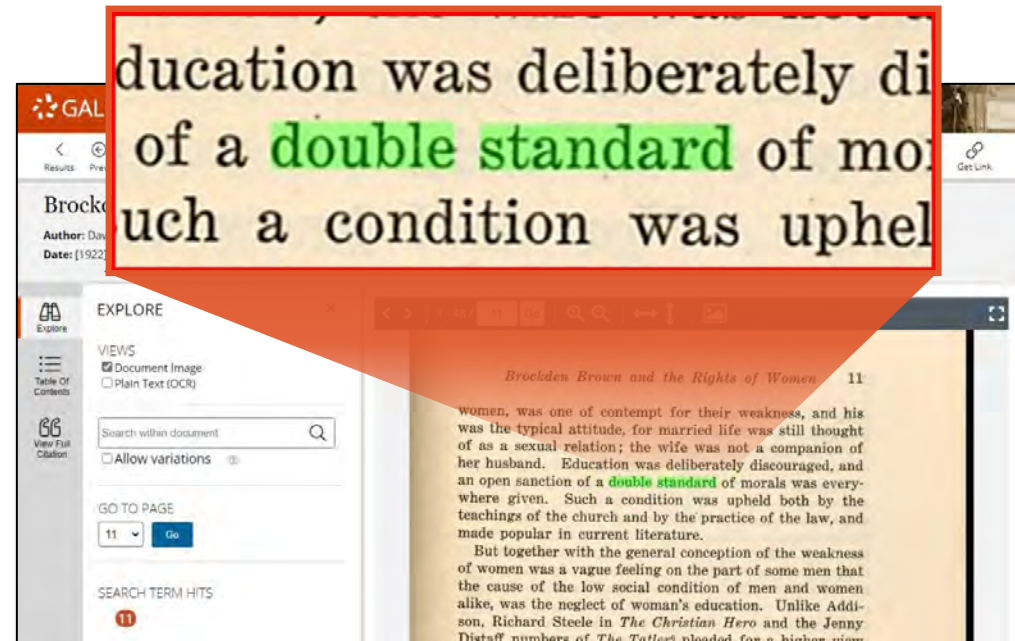

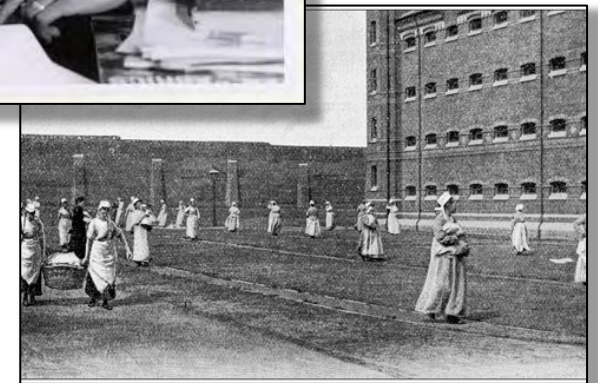

Dear Darr Smith:

Excerpts from your column dated July 15, 1949, in which you quote from an interview with Alfred Werker, director of "Lost Boundaries," has just been brought to my attention. I am appalled and not a little fighting mad to think that a so-called intelligent adult could be so viciously ignorant as to give as his reason for not casting Negroes in the above mentioned picture that "the majority of Negro actors are of the Uncle Tom, Minstrel show, shuffling dancer type of performer."

There are many Negro actors and actresses who are consistently turned down for plays and screen fare on the excuse that they are too fair, too intelligent, too modern looking, etc.. I know, because I am one who falls into this category. It was I who played the role of "Peola" the neurotic, sensi-

actresses who are far more intelligent than Werker proves himself to be.

No, Werker's excuse for denying to us our right to express ourselves through the medium of screen, is not good enough. Indeed, his excuse is a gross insult to us as American citizens, as Negroes, and as actors. I, for one, do not intend for Alfred Werker to cover up his stupid error by defiling us. He is a liar on several counts. He calls his picture documentary. Well, perhaps his New Hampshire scenes may be documentary, but his Harlem scenes are a gross exaggeration. I live in Harlem, and I think I am a better judge of that area than Werker. His Negro hospital scenes are crummy and unclean looking, when, as a matter of fact, southern Negro hospitals are well appointed, have clean buildings. The nurses and doctors on the staffs of such hospitals are uniformly neat and trim. His crowning lie, of course, is merely an excuse for using white actors in Negro roles.

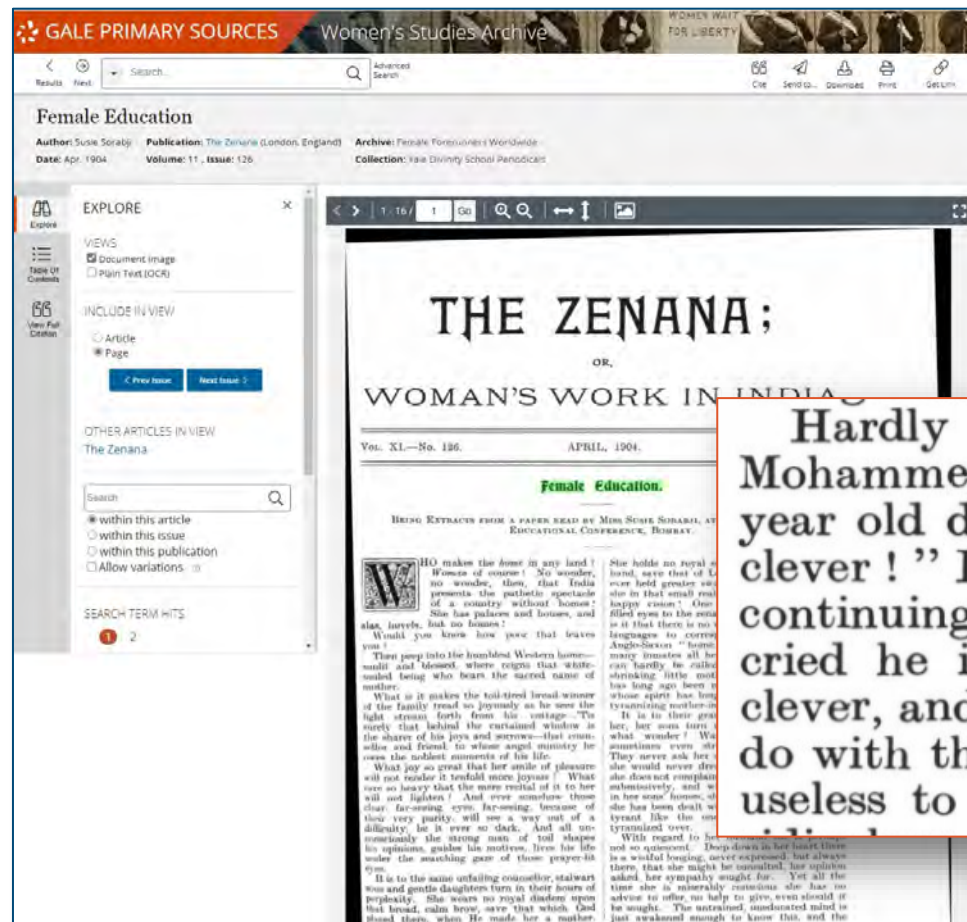

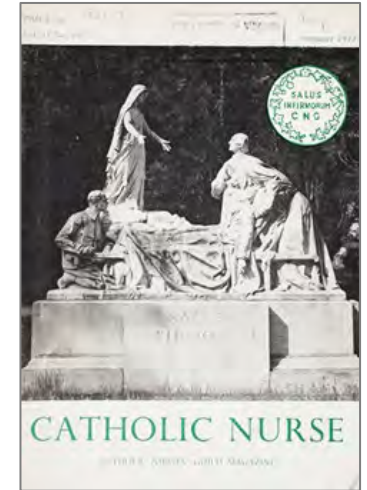

A nurse ought then to make her conscientious objection clear from the outset. On taking up a position at a hospital or other institution where abortion operations are carried out, she should write to the Secretary of the Management Committee or other appropriate official in the following or similar terms:

"Would you please note that I am not prepared to participate in or to assist at abortion operations. I give this notice in exercise of my right of conscientious objection under Section 4 of the Abortion Act 1967.

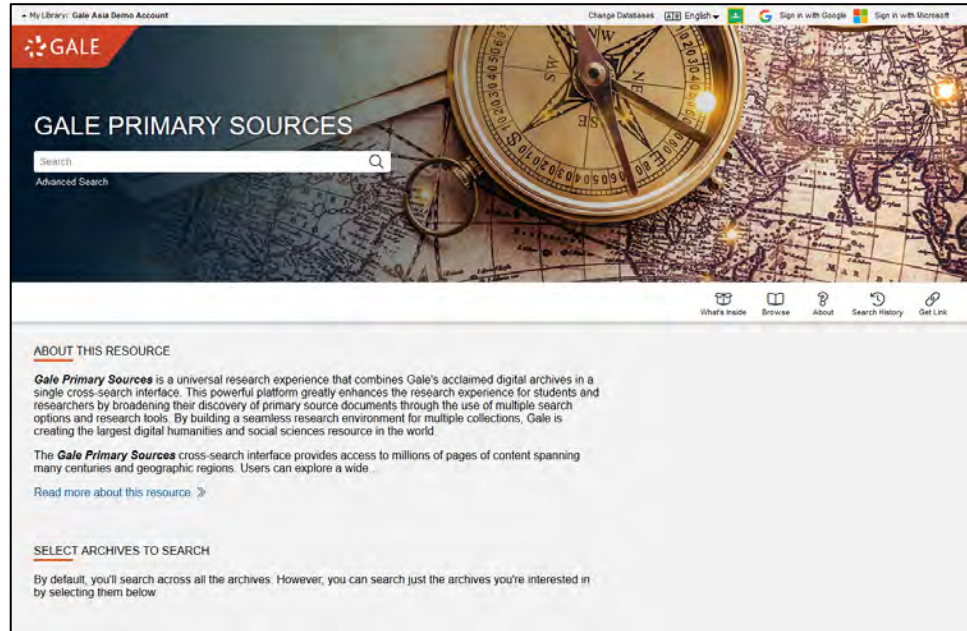

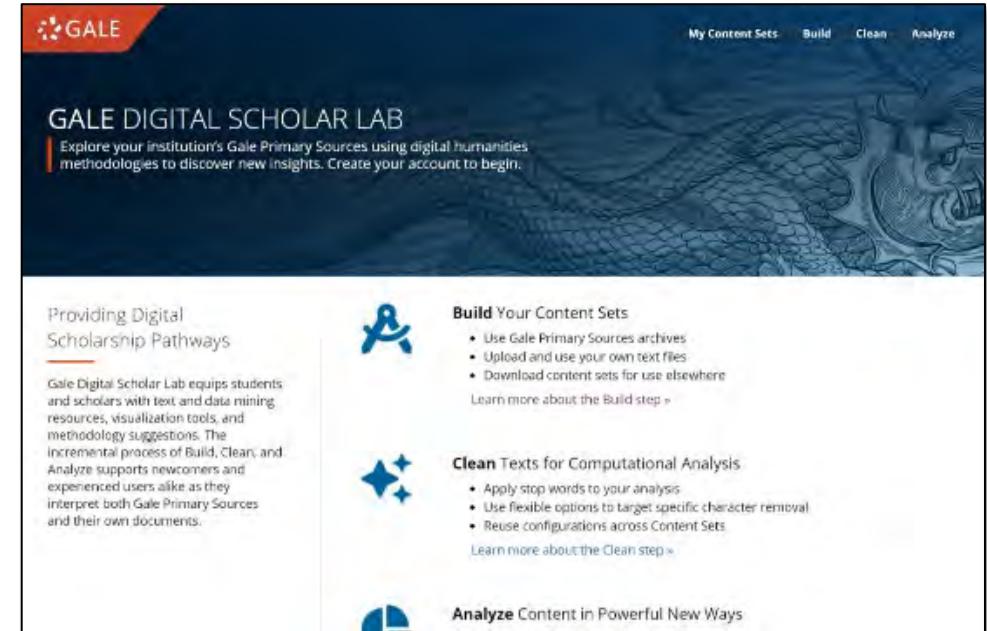
